



OCBC-GREAT EASTERN PICKLEBALL OPEN 2026 – OCBC Cardmembers and OCBC App Promotions

**Terms & Conditions for OCBC-Great Eastern Pickleball Open 2026 – OCBC Cardmembers
and OCBC App Promotions (“Promotions”)**

Eligibility

1. OCBC credit/debit card members will be entitled to a 10% discount off the prevailing registration fee when they sign up for OCBC-Great Eastern Pickleball Open 2026 (the “Event”) with their OCBC cards via the Official Event Website.
2. First 100 players who register from 24 July 2026 via the Official Event Website using OCBC App (“Players”) will receive S\$2 in cashback if they register for the applicable categories under clause 4 below (“Cashback”). The Cashback will be credited via PayNow to the mobile number provided in the Event’s registration form.
3. This Promotion is non-transferable and cannot be combined with other promotions unless expressly stated otherwise.

General

4. The Promotions are only applicable for registration under the following categories:
 - a) Open
 - b) Novice
 - c) Bank of Singapore Corporate Challenge (excluding group payment)
5. The eligibility of any Player to participate in the Promotions and/or enjoy any Cashback shall be determined at the absolute discretion of Oversea-Chinese Banking Corporation Limited (“Event Owner”).
6. The Event Owner reserves the right at its absolute discretion to terminate the Promotions or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any player and the dates of the Promotion.

The Event Owner shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotions, or any product and/or service relating to the Promotions. Notwithstanding anything herein, the Event Owner shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotions, and/or the use of any product and/or service relating to the Promotions, by any person.
8. The Event Owner's decisions on all matters relating to the Promotions shall be final and binding on all players. No correspondence or appeal shall be entertained by the Event Owner. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotions, these terms and conditions shall prevail.

The Event Owner shall not be responsible for any loss or damage to any person in connection with the Promotions howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.

11. These terms and conditions shall be governed by the laws of Singapore and each Player in the Promotions irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions.
